



## Floor Alert

### Support SB 1262 (Bradford)

We are nearly 50 businesses and associations and we urge your support of SB 1262.

Senate Bill 1262 restores the long-standing utilization of driver's license numbers (DLN) and dates of birth (DOB) in accessing California court electronic indexes for background checks.

Due to the prevalence of common names, this critical information is necessary to establish whether a court record belongs to a specific job or rental housing applicant. If businesses and organizations, including those who are legally mandated to perform background checks on

applicants, can no longer use search filters such as date of birth and driver's license number in conducting routine court records checks, they will be left with nothing but names, and little or no way to associate a court record with a specific individual. This is especially problematic with the prevalence of common names. Hundreds—indeed, thousands—of potential false positives will result, rendering record search results meaningless. Senate Bill 1262 will fix this situation by allowing the processing of background checks more efficiently and accurately.
